Come Sail Away Condominiums Rules & Regulations



- 1. Renters are liable for any damage to the facility and property resulting from their actions, or the actions of their guests.
- 2. Quiet hours will be strictly enforced between midnight and 6:00 am
- 3. The hallways, corridors and stairwells of buildings shall NOT be used as a playground.
- 4. All hallways, landings and stairwells are to be free of any articles (rafts, bikes, toys, coolers, fishing equipment, etc.)
- 5. No laundry or beach towels of any kind are permitted to hand outside of the unit.
- 6. All bicycles are to be kept in the bike racks.
- 7. Absolutely NO grills allowed on balconies, decks, grass area or docks. Please use the grills provided.
- 8. No boating, fishing or recreational gear or equipment may be stored on the docks. All dock lines and other connections must be kept in an orderly manner.
- 9. NO PETS are permitted in rental units.
- 10. Guests using the pool, Jacuzzi or deck area must be accompanied by a Come Sail Away occupant.
- 11. NO GLASS containers or bottles are permitted on the docks or in the pool area.
- 12. All vehicles must be parked in a designated parking area. NO BOATS, TRAILERS, CAMPERS, OR ANY VEHICLE LARGER THAN A VAN FRAME, SNOWMOBILES OR JET SKIS shall be permitted on the grounds or in the parking lot.
- 13. Vehicles must display a current parking permit or the vehicle will be towed at the vehicle owner's expense.
- 14. No guest shall use more than two (2) parking spaces.
- 15. Maintenance or washing of any vehicle in the parking lot is strictly prohibited.
- 16. No fueling of boats or heavy mechanical work is permitted at the docks.
- 17. Only authorized boats are permitted in the dock area. Unauthorized boats or boats docked in an improper manner will be towed at the boat owner's expense.
- 18. Sailboats must have halyards secured away from the mast. Sailboats shall not operate under sail within the harbor.
- 19. No mooring lines or water lines may be wrapped or tied to electrical pedestals or water faucets.
- 20. NO SWIMMING OR FISHING in the harbor.
- 21. No watercraft shall be moored or operated in a manner as to interfere with the normal navigation of another watercraft.
- 22. ABSOLUTELY NO FISH CLEANING anywhere on the Come Sail Away premises.
- 23. No overboard discharge of any marine toilet or holding tank, regardless of type of treatment, is permitted
- 24. NO WAKE LAW will be strictly enforced.

Rules & regulations are continuously being updated by the Come Sail Away Board of Directors. It is possible that upon arrival a modified rules & regulations pamphlet will be issued.
